

## **COREX LOGISTICS LIMITED PRIVACY POLICY**

Effective as of May 24, 2018, last update 05.02.2021

This Privacy Policy provides for terms and conditions under which COREX LOGISTICS LIMITED, further referred to as the Company, a legal entity registered and operating at Suite 40, the Guinness Enterprise Centre, Taylors Lane, Dublin 8, Ireland, processes personal data.

### **The Company ensures:**

1. High level of protection of personal data
2. Lawfulness, fairness, and transparency of processing
3. Accuracy of data
4. Security of processing
5. Keeping data no longer than is necessary for the purposes of collection
6. Adequate, relevant, and limited to what is the necessary scope of data
7. The principles of purpose specification and purpose limitation are followed

The Company may act as the data controller while processing personal data for the purposes described herein, as well as be engaged as a data processor by its counterparties based on agreements with them. ### **Types of collected information**

The Company may collect the following information:

- name and family name, job title, and information concerning person`s organization;
- contact details, including phone number, e-mail address, social media/messaging service (Skype, WhatsApp, etc.) accounts, and numbers;
- business correspondence with the Company, and/or for purposes of contract execution.

The Company will use personal data for the purpose it was collected this may include the following purposes:

- to perform the services under Company`s contracts with clients, vendors, employees;
- to increase the quality of provided services;
- to expand the level of the Company`s employees protection;
- to protect Company`s potential and current clients in their experience with Corex Logistics Limited cooperation and to keep records for the future cooperation on the same basis;
- to safeguard Company`s current vendor's records and personal information;
- to provide needed information to the regulatory authorities in cases where it is required by law;
- in case of receiving unambiguous, freely-given and explicit consent to send a promotional email, presentations, service proposals, special offers, newsletters,

business initiatives, and an invitation to the Company`s online study projects and webinars;

No automated decision-making activities (profiling, etc.) are being carried out by Corex Logistics Limited. The Company does not use any source of the personal data other than information provided by the data subject directly or made available to the public or obtained from the public domain. Additionally, personal data that were lawfully, fairly, and in a transparent manner collected may also be processed by the following processors: Company`s affiliates, as well as partner firms engaged in joint or partnership activities with Corex (exclusively necessary for the performance of activities needed to conduct services under the Contract, moreover third Parties to which personal data will be provided are specifically mentioned in the Contract with all necessary details); Corex Logistics accounting, HR, Legal, IT departments acting on the basis of internal Privacy Policy. Personal data may be transferred to third parties mentioned above, which are located outside the European Union that is why Corex Logistics Limited adopts all necessary safeguards to ensure the safety of personal data (including usage of Standard Contractual Clauses as set forth by EU Commission, implementation of technical and organizational security measures, ).

### **Data Subject Rights**

Data Subject has the following rights regarding its personal data:

- right of access which means the right to know whether data is being processed and to access it;
- right to rectification through providing a supplementary statement about missing, incomplete or incorrect information;
- right to erasure or right to be forgotten, among others if personal data has been made public;
- right to require the restriction of processing in cases provided by law;
- right to data portability;
- right to object to a personal data processing to be done or going on;
- right to withdraw consent for personal data processing;
- all rights that are guaranteed by applicable legislation.

### **Personal Data Retention Period**

The personal data will be retained for 5 years after the last contract, or after the Company achieved the results for which that data was collected, or unless the Company has received a request for the erasure of personal data or their restrictions of processing in place, or other cases required by the applicable law.

The data subject has the right to view, amend, or delete the personal information concerning him or her.

### **Rectification of personal information**

In case any of the information which Company holds on the data subject is inaccurate or incomplete, that data subject may ask Company to correct or complete it at any time.

## **Right of erasure, or to be forgotten**

The data subject may request the deletion of any personal data which the Company holds at any time. Be aware that requesting deletion, unlike unsubscribing from specific emails, is resulting in a full erasure from the Company`s systems. In the situation where the data subject re-joins Company systems, that data subject will appear as a completely new data subject. This does not affect other data subject`s rights in any way. ## **Cookie Policy**
